The following information is provided pursuant to the requirements of NRS 233B.0603:

1. Need for and purpose of the proposed regulation.

The proposed regulation is, in part, required because of passage of Senate Bill 447 ("S.B. 447") during the 81st Session of the Nevada Legislature (2021); the proposed amended regulation provides a statutorily-mandated review and update to chapter 598 of Nevada Administrative Code ("NAC") that streamlines and clarifies various hearing procedures, adds definitions for the benefit of the parties, removes requirements that no longer serve judicial efficiency, and promotes technological advancements while maintaining due process.

2. If the proposed regulation is a temporary regulation, either the terms or substance

of the proposed regulation or a description of the subjects and issues involved.

The proposed regulation is not a temporary regulation.

3. If the proposed regulation is a permanent regulation, a statement explaining how to obtain the approved or revised text of the proposed regulation prepared by the Legislative Counsel pursuant to NRS 233B.063.

A copy of the proposed regulation for adoption, LCB File No. R058-22, which includes amendments to date, is attached. 4. A statement of the estimated economic effect of the regulation on the business which it is to regulate and on the public.

Adverse/beneficial effects on business:

The Department has preliminarily determined that the proposed regulation will not (1) impose a direct and significant economic burden upon a small business; (2) result in any direct or indirect adverse effects on small businesses; or (3) directly restrict the formation, operation, or expansion of a small business. Beneficial effects of the proposed regulation on small businesses include including streamlining and clarifying various hearing procedures, adding definitions for the benefit of the parties, removing requirements that no longer serve judicial efficiency, and promoting technological advancements while maintaining due process.

Adverse/beneficial effects on the public:

The Department has preliminarily determined that the proposed regulation will not have an adverse economic effect on the public or result in any direct or indirect adverse effects on the public. Beneficial effects of the proposed regulation on the public include greater consumer protections for individuals and businesses due to a streamlined and increasingly efficient administrative hearing process.

Immediate/long-term effects on business:

The Department has preliminarily determined that the proposed regulation will not have any immediate or long-term adverse effects on small businesses and likely will have immediate or long-term beneficial effects on small businesses, given the streamlined and clarified hearing procedures, additional definitions for the benefit of the parties, removal of requirements that no longer serve judicial efficiency, and promotion of technological advancements that maintain due process.

Immediate/long-term effects on the public:

The Department has preliminarily determined that the proposed regulation will not have any immediate or long-term adverse effects on the public and likely will have immediate or long-term beneficial effects on the public through greater consumer protections for individuals and businesses due to a streamlined and increasingly efficient administrative hearing process.

5. A statement identifying the methods used by the agency in determining the impact on a small business.

The Department's determination is based on the following reasons:

- The proposed regulation conforms chapter 598 of the NAC to existing law.
- The proposed regulation does not impose additional burdens that were not already contained within the existing regulation, nor does it directly or indirectly restrict the formation, operation, or expansion of a small business.
- The proposed regulation has a beneficial effect on small businesses by streamlining and clarifying various hearing procedures, adding definitions for the benefit of the parties, removing requirements that no longer serve judicial efficiency, and promoting technological advancements while maintaining due process.

In addition, on March 12, 2024, the Department posted the proposed regulation on its website and subsequently issued a Notice of Public Workshop & Agenda concerning the proposed regulatory changes to NAC 598 on March 27, 2024. The Department made email notification to all persons on the Nevada Consumer Affairs Unit's email list, requesting comments and input concerning whether the proposed regulation was likely to impose a direct and significant economic burden on small business.

The Department does not anticipate any additional costs to the agency for enforcement of the proposed regulation. The proposed amended regulation streamlines and clarifies various hearing procedures, adds definitions for the benefit of the parties, removes requirements that no longer serve judicial efficiency, and promotes technological advancements while maintaining due process – all of which will have a beneficial effect by reducing costs to the agency.

A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. REVISED PROPOSED REGULATION OF THE

COMMISSIONER OF CONSUMER AFFAIRS OF THE

DEPARTMENT OF BUSINESS AND INDUSTRY

LCB File No. R058-22

June 10, 2022

EXPLANATION: Matters in (1) *blue bold italics* is new language in the original bill; (2) *green bold italics* is language proposed to be added in this amendment; (3) [red strikethrough] is deleted language in the original bill; (4) and [purple bold strikethrough] is language proposed to be deleted in this amendment.

AUTHORITY: § 2, NRS 598.0967, 598.0971, 598.525, 598.845 and 598.9474; § 3, NRS 598.0967, 598.515, 598.525, 598.8541 and 598.9476; §§ 1, 4-7, 10, 12, 13, 15-21 and 24-33, NRS 598.0967, 598.506, 598.525, 598.854 and 598.9474; §§ 8, 9, 14 and 36, NRS 598.0967; § 11, NRS 598.0967, 598.471, 598.852 and 598.944; §§ 22 and 23, NRS 598.0967 and 598.0971; §§ 34 and 35, NRS 598.0967 and 598.525.

A REGULATION relating to deceptive trade practices; establishing the manner in which the costs of certain investigations, audits and hearings of the Consumer Affairs Unit of the Department of Business and Industry are calculated; replacing references to the Consumer Affairs Division of the Department with the Consumer Affairs Unit; requiring a registrant with the Unit to submit certain notices to the Unit; revising provisions governing orders to show cause issued and hearings held by the Unit; revising definitions related to deceptive trade practices; repealing provisions governing sellers of travel; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Senate Bill No. 447 of the 2021 Legislative Session eliminated the Consumer Affairs Division of the Department of Business and Industry and made permanent the Consumer Affairs Unit in the Department of Business and Industry. (NRS 232.510) **Sections** 8-10, 12, 16-26, 28-29, 36, and 39-41 [7-9, 12, 14-24, 26, 27, 30 and 33-35] of this regulation make conforming changes as a result of the elimination of the Consumer Affairs Division and the permanent creation of the Consumer Affairs Unit.

Under existing law, the Unit and the Commissioner of Consumer Affairs are charged with carrying out certain duties relating to the enforcement of laws prohibiting deceptive trade practices and the regulation of certain businesses, including, without limitation, sightseeing tours, organizations for buying goods or services at a discount, dance studios and health clubs. (Chapter 598 of NRS)

If, after investigation, the Commissioner or Attorney General has reasonable cause to believe that any person has been engaged or is engaging in any deceptive trade practice, existing

law authorizes the Commissioner or Attorney General to issue an order to that person to show cause why the Director of the Department should not order the person to cease and desist from engaging in the practice and pay an administrative fine. If the Director or his or her designee determines that the person has been engaged or is engaging in a deceptive trade practice, existing law authorizes the Director or his or her designee to issue an order requiring the violator to pay the costs of conducting the investigation, conducting the hearing, any reporting services, renting a hearing room if one is not available free of charge and certain other costs. (NRS 598.0971)

Section 2 of this regulation establishes the manner in which the costs of conducting an investigation, audit or hearing pursuant to chapter 598 of NRS and chapter 598 of NAC must be calculated.

Existing regulations provide that a party who wishes to contest an order to show cause may file an answer with the Division that must, in relevant part, admit or deny each material allegation with specificity. (NAC 598.144) **Section 28**[24] of this regulation requires the party to file such an answer within 10 calendar days after the day the order to show cause is received and admit or deny each allegation [with specificity, regardless of whether the allegation is material].

If the Commissioner is unable to preside over a hearing and does not designate a hearing officer, existing regulations require the Director to appoint a hearing officer to preside over the hearing. (NAC 598.156) **Section** 32[28] of this regulation requires the Director to appoint a hearing officer [if the Commissioner does not designate one, regardless of whether the Commissioner is able to preside over the hearing].

Existing regulations authorize the Division to issue a subpoena or subpoena duces tecum before or during a hearing if good cause is shown. (NAC 598.146) **Section 29[25]** of this regulation removes this authority from the Division and authorizes the Commissioner, Director or the *hearing officer [Director's designee]* to issue a subpoena or subpoena duces tecum.

Existing regulations require that a hearing be recorded using equipment for recording sound or reported by a certified court reporter. (NAC 598.160) Existing regulations also require the temporary retention of the transcribed record of a hearing, which must be made available upon request, and authorize a party to the hearing to obtain a copy of the transcript from the official reporter for a fixed fee. (NAC 598.168, 598.170) **Section** 34[29] of this regulation requires that such a hearing be recorded using equipment for recording sound, unless a party requests and pays for a certified court reporter. **Section** 37[31] of this regulation makes a conforming change by requiring: (1) the temporary retention of the stenographic record or sound recording of a hearing; and (2) that the sound recording be made available to a party upon request. **Section** 38[32] of this regulation authorizes a party to purchase a copy of the transcript of a hearing from the certified court reporter.

Existing law requires tour brokers and operators, organizations for buying goods or services at a discount, dance studios and health clubs to register with the Division and to deposit a security to be held in trust for consumers injured by the bankruptcy of the registrant or the registrant's breach of any agreement entered into in his or her capacity as a registrant. (NRS 598.506, 598.854, 598.9474) **Sections 14[0], 15[1] and 17[3]** of this regulation revise definitions related to such registrants. **Section 7[6]** of this regulation requires a registrant to notify the Unit in writing of any claims filed against the security of the registrant.

Existing law authorizes the Unit to conduct a hearing to determine the distribution of the security of a registrant to claimants. (NRS 598.506, 598.854, 598.9474) If the Unit decides to take action against the security of a registrant, existing regulations require the Unit to request that the registrant appear and show cause why the Unit should not take the intended action. (NAC 598.136; sections 10 and 11 of Senate Bill No. 447, chapter 423, Statutes of Nevada 2021, at

page 4749) **Section**[s] 4 [and 5] of this regulation prescribe the contents of such an order to show cause and the manner in which it must be served upon the respondent. Sections 5 and 27 provide the opportunity for a prehearing conference at the discretion of the hearing officer.

Existing law requires that the Commissioner determine the date on which a registrant has ceased to operate so that the Commissioner may release to the registrant the security deposited with the Unit, if no claims have been filed against that security within 6 months after the registrant has ceased to operate. (NRS 598.515, 598.8541, 598.9476) **Section 3** of this regulation requires such a registrant to notify the Unit in writing within 10 days after the registrant ceases to operate.

Existing regulations authorize the Commissioner to disclose information about the number of complaints that: (1) are currently under investigation by the Division; (2) have been resolved by the Division; and (3) were received by the Division on any specific day. (NAC 598.115) **Section 18**[4] of this regulation authorizes the Commissioner or the Director to disclose such information with respect to the Unit.

Section *42[36]* of this regulation repeals provisions relating to *certain administrative procedures and* sellers of travel.

- **Section 1.** Chapter 598 of NAC is hereby amended by adding thereto the provisions set forth as sections 2 to 7[6], inclusive, of this regulation.
- Sec. 2. 1. The cost of conducting an investigation or audit pursuant to this chapter or chapter 598 of NRS must be calculated at a rate of not more than \$\{28\}50\$ per hour as set by the Director.
- 2. The cost of conducting a hearing pursuant to this chapter or chapter 598 of NRS must be calculated at a rate of not more than \$[28]50 per hour as set by the Director.
 - 3. For the purposes of NRS 598.0971:
- (a) The charges for the rental of a hearing room shall be deemed to be the actual charges incurred by the Unit for the rental of the room used or reserved for the hearing.
- (b) The charges for providing an independent hearing officer shall be deemed to be the actual fees and costs charged by the independent hearing officer.
- Sec. 3. A registrant shall notify the Unit in writing within 10 days after ceasing to operate.
 - Sec. 4. 1. A[n] complaint and order to show cause issued pursuant to subsection 3 of

NAC 598.136 must be:

- (a) [s]Served upon the respondent directly, by certified [registered] or registered [certified] mail, [with] return receipt requested, or in any other manner permitted by the Nevada Rules of Civil Procedure for the service of process in civil actions[,]; and
- (b) Served upon the respondent at least 10 calendar days before the date of the hearing, unless the requirement that service be made within that time is waived by the respondent.
- 2. A[n] complaint and order to show cause issued pursuant to subsection 3 of NAC

 598.136 must [bear an identifying number assigned by the [Division] Unit and must] include, without limitation:
 - (a) An identifying number assigned by the Unit;
- (b[a]) A brief and concise description of the matters asserted by the claimant who alleges he or she was injured by the bankruptcy of the respondent or by the respondent's breach of an agreement entered into in his or her capacity as a registrant;
- (c[b]) A reference to any specific statutory provisions the respondent is alleged to have violated;
- (d[c]) A statement that there is reasonable cause to believe the respondent violated the provisions in (c) [A notice of the hearing to show cause that sets forth the date, time and place of the hearing];
- (e[d]) A signature by an employee of the Unit or an employee of the Attorney

Sec. 37[31]. NAC 598.168 is hereby amended to read as follows:

598.168 [1.] The [transcribed] stenographic record or sound recording of a hearing will be retained for 90 days after the date of the decision and order, at which time it will be destroyed or reused, unless a petition for judicial review has been filed pursuant to chapter 233B of NRS.

[2. A certified copy of the transcription will be made available to a party upon request at the Division.] A copy of the sound recording will be made available to a party upon request.

Sec. 38[32]. NAC 598.170 is hereby amended to read as follows:

598.170 1. A party may [obtain] purchase a copy of the transcript of a hearing from the official certified court reporter upon payment of the costs and fees [fixed therefor.] charged by the official court reporter for preparing the transcript.

2. A party who files a petition for judicial review pursuant to chapter 233B of NRS may purchase a copy of the transcript of the hearing at an amount equivalent to the costs or fees charged by the official reporter for preparing the transcript.

Sec. 39[33]. NAC 598.172 is hereby amended to read as follows:

598.172 Payment of any costs, fees, fines, penalties, charges or restitution authorized by statute or regulation to be collected by the [Division,] Unit or Attorney General, or ordered by the [Commissioner or the Director] hearing officer to be paid by a party pursuant to [paragraph (b), [or] (c) or (d) of subsection [2] 3 of] NRS 598.[0971]0903 to NRS 598.0999 or any regulation must be made by cashier's check, money order, [or] other certified instruments, or any method of electronic transfer of money allowed by the Unit or Attorney General, if required, payable to the [Division.] Unit or Attorney General.

Sec. 40[34]. NAC 598.550 is hereby amended to read as follows:

- 598.550 1. Each tour broker and tour operator shall register with the [Division] *Unit* on a form provided by the [Division.] *Unit*. An applicant for registration shall include with his or her application the required security in proper form.
- 2. Upon receipt of an application for registration from a tour broker or tour operator that includes the required security in proper form, the [Division] *Unit* will issue a certificate of registration to the tour broker or tour operator. The certificate of registration is not transferable or assignable.
 - 3. A tour broker or tour operator shall display the certificate of registration in an area within

his or her business so that the certificate of registration is visible to the public.

Sec. 41[35]. NAC 598.560 is hereby amended to read as follows:

- 598.560 1. A disclosure or notice required of a tour broker or tour operator pursuant to NRS 598.475 must set forth the required information in bold type at least 2 points larger than the type used in the majority of the document in which the information appears.
- 2. The notice on a billing invoice or receipt given to a customer for a sightseeing tour must set forth the information in substantially the following form and include Unit's physical addresses as provided for on the Unit's website and a link to the Unit's website immediately above the telephone contact information:

FOR THE SIGHTSEEING TOUR BECAUSE ITS INCLUSION WOULD VIOLATE A STATE OR FEDERAL STATUTE OR REGULATION.

TEXT OF REPEALED SECTIONS

598.103 "Complaint" defined. (NRS **598.0967**, **598.731**) "Complaint" means a written or oral statement of facts made by a person that provides evidence that a registrant has been engaged

or is engaging in a deceptive trade practice.

598.1045 "Division" defined. (NRS 598.0967, 598.731) "Division" means the Consumer Affairs Division of the Department of Business and Industry.

598.110 Informal resolution of complaint through memorandum of understanding.

- 1. The Commissioner and a person alleged to have committed a deceptive trade practice may informally resolve any complaints involving the deceptive trade practice by entering into a memorandum of understanding.
 - 2. The memorandum of understanding must:
 - (a) Be in a form approved by the Commissioner; and
- (b) Provide for payment of restitution by the person alleged to have committed a deceptive trade practice to each consumer aggrieved by that deceptive trade practice.
- 3. The memorandum of understanding must not be used to assess penalties or the costs of investigating a complaint against the alleged violator.
- 4. By executing a memorandum of understanding pursuant to this section, the Commissioner is not precluded from initiating civil proceedings or accepting an assurance of discontinuance from a person pursuant to NRS 598.0979 if the Commissioner determines that the alleged violator breached the terms of the memorandum of understanding or committed or attempted to commit a deceptive trade practice after the execution of the memorandum of understanding.
- 5. Execution of a memorandum of understanding does not affect the right of a consumer to pursue a private remedy against a person alleged to have committed a deceptive trade practice.
 - 6. A memorandum of understanding is not an admission of a violation for any purpose.
- **598.142 Order to show cause: Form. (NRS 598.0967, 598.731)** An order to show cause must be in substantially the following form, but may include other information:

598.144 Order to show cause: Answer; objections to form. (NRS 598.0967, 598.731)

- 1. A party who wishes to contest an order to show cause may file an answer with the Division.

 The answer must:
 - (a) Be in writing;
 - (b) Admit or deny each material allegation with specificity; and
- (c) State with specificity any facts constituting a defense to the allegations, including, but not limited to, all affirmative defenses that are being asserted in response to the allegations.

- 2. Unless the respondent states an objection to the form of the order to show cause in the answer, the respondent shall be deemed to have waived all objections to the form of the order to show cause.
- 3. If the respondent objects to the form of the order to show cause, the respondent shall identify with specificity why he or she objects to the form of the order.

598.148 Affidavits. (NRS 598.0967, 598.731)

- 1. A party that wishes to have an affidavit introduced in evidence at any hearing of the [Division] *Unit* must, at least 10 days before the date set for hearing, serve upon the opposing party, either personally or by registered or certified mail, return receipt requested, a copy of the affidavit which is proposed to be introduced in evidence.
- 2. A notice, in substantially the following form, must be served upon the opposing party at the same time:

The accompanying affidavit of (name of affiant) will be introduced in evidence at the hearing set for the(day) of(month) of(year). (name of affiant) will not be called to testify orally and you will not be entitled to cross-examine (name of affiant) unless you place in the mail or personally deliver to the undersigned your request to cross-examine (name of affiant) not later than 7 days after the date on which this notice and the enclosed affidavit were served upon you.

(Telephone number)

- 3. Unless the opposing party, within 7 days after service of a copy of the affidavit and notice, places in the mail, as evidenced by the postmarked date on the envelope, or personally delivers to the party proposing to introduce the affidavit a request to cross-examine the affiant, the opposing party shall be deemed to have waived his or her right to cross-examine the affiant, and the affidavit, if introduced in evidence, must be given the same weight as if the affiant had testified orally.
- 4. If an opportunity to cross-examine an affiant is not afforded to the opposing party after the opposing party so requests pursuant to this section, the affidavit may be introduced in evidence, but the affidavit must be given the same weight as other hearsay evidence.

598.166 Review of order; entry of final order; filing of petition for judicial review. (NRS 598.0967, 598.731)

- 1. If the hearing officer is a designee of the Commissioner or Director, the Director will review the order and enter the final order affirming, modifying or setting aside the decision.
- 2. If a decision is rendered orally, the time to file a petition for judicial review does not begin to run until:
- (a) The decision and order are reduced to writing and signed by the Commissioner or Director; and
 - (b) Written notice of the decision and of the order is mailed, postage prepaid, to the parties.598.174 Rehearing. (NRS 598.0967, 598.731)
- 1. If a petition for judicial review of the decision has not been filed, upon written application by a party within 15 days after service of a copy of the decision and order, a rehearing may be ordered upon such terms and conditions as the hearing officer considers just and proper.
 - 2. An application for rehearing must not be granted except upon a showing that:
 - (a) A party was not properly served with a notice to appear;

- (b) There is additional evidence that is material, necessary and reasonably calculated to change the decision of the hearing officer, and good cause existed for the failure to present that evidence at the hearing;
- (c) A material fact or point of law was overlooked or misconstrued as set forth in the decision; or
 - (d) There has been a change in the laws affecting the decision.
 - 3. The application for rehearing must:
- (a) Be supported by an affidavit of the party or his or her counsel showing cause for failing to appear or failing to present the evidence at the hearing;
 - (b) State with particularity:
- (1) The reason why the additional evidence is necessary and material and why the additional evidence was not introduced at the hearing; or
- (2) The material fact or point of law which, in the opinion of the party, has been overlooked or misconstrued;
- (c) Contain every argument in support of the position of the party that he or she desires to present;
 - (d) Not exceed 10 pages in length; and
 - (e) Be served upon the opposing party at least 10 days before the date of the rehearing.
- 4. Matters already presented in briefs or oral arguments may not be reargued in the application for rehearing. No point may be raised for the first time in an application for rehearing.
- 5. A party may file and serve an answer to the application for rehearing. The answer must be filed within 5 days after the party receives the application for rehearing.

- 6. An application for rehearing does not operate to stay the order or excuse compliance with or suspend the effectiveness of the challenged order, except as otherwise ordered by the Commissioner or the Director.
 - 7. An application for rehearing does not toll the time for filing a petition for judicial review.
 - 8. Oral argument on an application for rehearing must not be allowed.
- 9. If an application is granted, upon rehearing, rebuttal evidence to the additional evidence must be allowed. After rehearing, the Commissioner or the Director may modify his or her decision and order as the additional evidence may warrant.
 - 598.500 Display of certificate of registration. (NRS 598.0967) A seller of travel shall display the certificate of registration issued by the Division to the seller of travel pursuant to NRS 598.365 in an area within his or her business so that the certificate of registration is visible to the public.

598.510 "Seller of travel" exclusions interpreted. (NRS 598.0967)

- 1. With regard to a hotel that provides or arranges travel services for its patrons or guests, the exclusion for the term "seller of travel" as set forth in subsection 2 of NRS 598.335:
 - (a) Applies only to persons actually employed by the hotel.
- (b) Does not apply to lessees, independent contractors and other persons who are not employees of the hotel.
- 2. With regard to a person who, for compensation, transports persons or property by air, land, rail or water, the exclusion for the term "seller of travel" as set forth in subsection 2 of NRS 598.335 applies only to persons whose businesses are limited to providing such transportation.
- **598.520** Exemption from security requirement. (NRS 598.0967) The security requirement set forth in NRS 598.375 that a seller of travel deposit with the Division a bond, irrevocable letter of credit or certificate of deposit does not apply to a person engaged in business

as a seller of travel if the person submits to the Division, in such form as the Division prescribes, evidence satisfactory to the Commissioner that the person is an employee, agent or independent contractor of a seller of travel who:

- 1. Is in compliance with the requirement to provide such security and that the person is covered by the security deposited with the Division by the seller of travel; or
 - 2. Is exempt from the requirement to provide such security.

LCB File No. R058-22 Small Business Impact Statement pursuant to NRS 233B.0608:

(a) A description of the manner in which comments were solicited from affected small business, a summary of their response and an explanation of the manner in which other interested persons may obtain a copy of the summary.

The Department of Business and Industry intends to solicit comments on the proposed regulation as part of the public workshop scheduled for March 27, 2024. Comments from the workshop will be incorporated into the small business impact statement and posted with the notice of adoption.

(b) The manner in which the small business analysis was conducted for LCB File No. R058-22.

Pursuant to NRS 233B.0608(1), the Department made a concerted effort to determine whether the proposed amended regulation is likely to impose a direct and significant economic burden upon a small business; or directly restrict the formation, operation or expansion of a small business. For this effort, the Department used the definition of a "small business" as provided in NRS 233B.0382: "[A] business conducted for profit which

employs fewer than 150 full-time or part-time employees."

Following review and analysis of the authorizing statutory language (Senate Bill No. 447 (2021)) and hearing procedures in other branches of Nevada government, the Department has preliminarily determined (as further described below) that the amended regulation is unlikely to impose a direct and significant economic burden upon a small business; result in any direct or indirect adverse effects on small businesses; or directly restrict the formation, operation, or expansion of a small business.

The proposed amended regulation conforms chapter 598 of the NAC to existing law by updating the name of the Consumer Affairs Division of the Department of Business and Industry to the Consumer Affairs Unit in the Department of Business and Industry. The proposed amended regulation establishes registrant duties and notice requirements related to the Unit's pre-existing authority to determine the distribution of the security of a registrant to claimants. The proposed amended regulation streamlines and clarifies various hearing procedures, adds definitions for the benefit of the parties, removes requirements that no longer serve judicial efficiency, and promotes technological advancements while maintaining due process.

Pursuant to existing law, the Department has authority to collect reimbursement for the cost of conducting an investigation, audit, or conducting a hearing. The proposed amended regulation establishes the amount the Department can charge. The proposed amended regulation further provides a process by which registrants and the public can obtain documents for a nominal fee or electronically without charge.

(c) The estimated economic effect of the proposed regulation on the small businesses which it is to regulate, including, without limitation:

(1) Both adverse and beneficial effects:

(I) Adverse effects:

As described above, the Department has preliminarily determined that there will be no adverse effects on small businesses because the proposed regulation streamlines and clarifies various hearing procedures, adds definitions for the benefit of the parties, removes requirements that no longer serve judicial efficiency, and promotes technological advancements while maintaining due process. The Department will continue to solicit further input as part of the workshop scheduled for March 27, 2024.

(II) Beneficial effects:

There are numerous beneficial effects of the proposed regulation, including streamlining and clarifying various hearing procedures, adding definitions for the benefit of the parties, removing requirements that no longer serve judicial efficiency, and promoting technological advancements while maintaining due process. Additional beneficial effects of the proposed regulation on small businesses will be determined by the Department after the workshop scheduled for March 27, 2024.

(2) Both direct and indirect effects.

(I) Direct effects:

Direct effects of the proposed regulation include streamlining and clarifying various hearing procedures, adding definitions for the benefit of the parties, removing requirements that no longer serve judicial efficiency, and promoting technological advancements while maintaining due process. Additional direct effects of the proposed regulation on small businesses will be determined by the Department after the workshop scheduled for March 27, 2024.

(II) Indirect effects:

The Department has determined that there are no indirect effects of the proposed regulation on small businesses, as all businesses are directly and beneficially affected similarly. The proposed regulation does not impose additional burdens that were not already contained within the existing regulation, but streamlines and clarifies various hearing procedures, adds definitions for the benefit of the parties, removes requirements that no longer serve judicial efficiency, and promotes technological advancements while maintaining due process. Additional indirect effects will be determined by the Department after the workshop scheduled for March 27, 2024.

(3) A description of the methods that the Department of Business and Industry considered to reduce the impact of LCB File No. R058-22 on small businesses and a statement whether the Department actually used any part of those methods.

As described above, the Department has preliminarily determined that there will be no adverse effects on small businesses. Therefore, the Department has not considered methods to reduce the impact of the proposed regulation on small businesses, as all businesses are directly and beneficially affected similarly. The proposed regulation does not impose additional burdens that were not already contained within the existing regulation, but instead streamlines and clarifies various hearing procedures, adds definitions for the benefit of the parties, removes requirements that no longer serve judicial efficiency, and promotes technological advancements while maintaining due process. Methods will be considered after the workshop scheduled for March 27, 2024, where the Department will receive comments from members of the public and small businesses on how the proposed regulation may impact them.

(4) The estimated cost to the agency for enforcement of the proposed regulation.

The Department does not anticipate any additional costs to the agency for enforcement of the proposed regulation. The proposed amended regulation streamlines and clarifies various hearing procedures, adds definitions for the benefit of the parties, removes requirements that no longer serve judicial efficiency, and promotes technological advancements while maintaining due process – all of which will have a beneficial effect by reducing costs to the agency.

(5) If LCB File No. R058-22 provides a new fee or increases an existing fee, the total annual amount the Department of Business and Industry expects to collect and the manner in which the money will be used.

Pursuant to existing law, the Department has authority to collect reimbursement for the cost of conducting an investigation, audit, or conducting a hearing. The proposed regulation establishes

the amount the Department can charge. The Department does not have an estimate of the number of hearings it expects to hold and therefore cannot estimate an approximate amount it would expect to collect from this reimbursement, but it believes hearings will be infrequent, rather than routine, and therefore the amount would be nominal. The Department intends to use this money to reimburse actual charges incurred by the Nevada Consumer Affairs Unit for rental of the room used or reserved for the hearing, and the actual fees and costs charged for use of an independent hearing officer if incurred.

(6) If LCB File No. R058-22 includes provisions which duplicate or are more stringent than federal, state or local standards regulating the same activity, an explanation of why such duplicative or more stringent provisions are necessary.

LCB File No. R058-22 does not duplicate any existing federal, state or local standards regulating the same activity.

(7) The reasons for the conclusions of the Department regarding the impact of LCB File No. R058-22 on small businesses.

The Department's preliminary conclusions are based on the following reasons:

- The proposed regulation conforms chapter 598 of the NAC to existing law.
- The proposed regulation does not impose additional burdens that were not already contained within the existing regulation, nor does it directly or indirectly restrict the formation, operation, or expansion of a small business.
- The proposed regulation has a beneficial effect on small businesses by streamlining and clarifying various hearing procedures, adding definitions for the benefit of the parties, removing requirements that no longer serve judicial efficiency, and promoting technological advancements while maintaining due process.

The Department may have additional information regarding any potential impact to small businesses after the scheduled workshop.
